Minutes of the Leonard Stanley Parish Council Meeting held on Tuesday 3<sup>rd</sup> November 2015 at 7.30 pm in the Village Hall.

## **Public Questions:-**

- Q.** Would the Parish Council consider contributing to the running costs of the Village Hall?
- A.** This could be considered when the budget is drafted.
- Q.** Will the Parish Council consider the name of 'Sandford' for the new development in Mankley Road.
- A.** This suggestion will be taken into consideration when discussing Agenda Item 93/15.

## **89/15. Declarations of Interest in Agenda Items**

## **90/15. To approve the minutes from the Parish Council Meeting held on Tuesday 6<sup>th</sup> October 2015**

*The minutes were approved and signed as a true record.*

## **91/15. To receive an update / reports from the County and District Councillors**

District Cllr Nigel Studdert-Kennedy reported:

- Garden Waste Scheme has been launched.
- Enforcement Action is being taken against the developers of Woodside Lane.
- Stroud Local Plan – with a few adjustments has been approved by the Inspector and will now go before Council to adopt.
- Multi Service Contract for waste collection; there has been a 75% reduction in bulky waste and fly tipping as a result is being monitored. The new depot is taking shape with negotiations ongoing for the new kit required. Staff transfer will be through TUPE. The new bins will start to be issued in August.

- Devolution, to see how councils can work together more closely - consultation under way.
- Mankley Road Development – Conifers to be removed and in time replaced by a Silver Birch or such like.

### **92/15. To consider signing up to the Armed Forces Covenant**

The Clerk explained that this is to provide a public statement of support.

The Armed Forces Covenant recognises that the whole nation has a moral obligation to members of the armed forces and their families, and it establishes how they should expect to be treated.

The covenant's 2 principles are that:

- the armed forces community should not face disadvantage compared to other citizens in the provision of public and commercial services
- special consideration is appropriate in some cases, especially for those who have given most such as the injured and the bereaved

Gloucestershire County Council is encouraging Town and Parish Councils to sign up to the Community Covenant which; encourages local communities to support the armed forces community in their area and promote public understanding and awareness.

*It was agreed to sign up to the Community Armed Forces Covenant.*

### **93/15 To consider a street name for the new development at Mankley Road**

*It was agreed to request that the new development at Mankley Road be named 'Sandford Close'.*

### **94/15. To receive an update from the latest meeting of the Community Design Statement Steering Committee**

The Chairman updated the Members on a recent meeting of the Steering Group.

Summary:-

- Hayley along with Heather and David Longworth have walked the entire boundary of the Parish and all the Footpaths within.
- Has sought clearly defined maps and will request a more detailed map of the streets.
- Had investigated examples of well put together Design Statements already completed.
- Agreed a new timetable, which should see the plan submitted to Stroud District Council for approval by the end of June 2016.

### **95/15. Playing Fields:- To receive an update**

i) **On the Flood Lights** – Cllr Stuart Craddock informed Members that the Football Club are looking at LED alternatives.

ii) **On borrowing a set of goal posts to be fixed down by the Tennis Courts** – this is still being looked into.

iii) **To receive a report on the outcome of use by ‘Kick off Stroud’** – Unfortunately, the half term week was rather wet and there was a poor turnout. It is not known whether Kick Off Stroud wish to try again another time.

iv) **To consider the issue of Dog Owners continuing to use the Playing Field** – there have been complaints that dogs are being exercised on the field.

It was agreed that additional signs are required.
