Minutes of the Leonard Stanley Parish Council Meeting held on Tuesday 4th September 2012 at 7.30 pm in the Lease Room, Village Hall.

Present:- Councillors W Bevan, C Connett, S Craddock, G Davies (Chairman), S Davies, R Gaunt, P Herbert and S Lydon.

Also Present:- District Cllr N Studdert-Kennedy, County Cllr Leslie Williams and Peter Ward Village Agent (Gloucestershire Rural Community Council).

70/12. Apologies for absence were received from Cllr D Targett, PCSO Liz Ward and Neighbourhood Warden Phil Drew.

71/12. Declarations of Interest in Agenda Items – There were none.

72/12. To approve the minutes from the Parish Council Meeting held on Tuesday 10th July 2012

The minutes were approved and signed as a true record.

73/12 Localism Bill 2011 – to adopt the New Standards Regime (Code of Conduct).

It was agreed to adopt the New Standards Regime (Code of Conduct).

74/12. To receive updates from the County and District Councillors

County Cllr Mrs Lesley Williams reported:

- The terms and conditions regarding the proposed Waste Incinerator are due next week.
- The County Council have intentions to tender for one organisation to manage the parking for the whole of the County.

District Cllr Nigel Studdert-Kennedy, stated that the Housing Strategy had under-estimated the amount of houses required, so these numbers have now been increased.

District Cllr Steve Lydon, stated that the Core Strategy will now focus on a 'lead on jobs' rather than houses. He further reported that due to a cut in funding, there will be a Shelter Housing Review, with a Banding System being introduced.

75/12 To receive an update from the Clerk

i. Steering Group for Play Facilities in the Recreation Park

The Clerk stated that the group have received a good response to the questionnaire and are currently collating the details. A new meeting will be set for this month.

ii. Goal posts in the Playing Fields.

The Clerk reported that the goals posts have been in place since the middle of July.

76/12. Village Champion – To discuss the setting up of an award for service to the community

The Chairman asked the Council if they would be in support of a setting up an award scheme to recognise outstanding contributions to the community. The Members were all in support and agreed to consider the idea and how best to implement this, with suggestions to be put forward at next months meeting. **ALL**

77/12. Recreation Park:

i) To discuss and agree what action should be taken in regard to access onto the Recreation Park

Following the 'Deposition' which protects the Recreation Park from no new Rights of Way being established in the next 10 years, it was agreed to further protect the Playing Fields from ensuring that no 'right to accesses' can be claimed.

It was agreed to draft a letter to all the properties that back onto the Playing Fields, to politely remind them that they do not have permission to access the Park from their properties. Although, it was recognised that the majority of householders do not infringe their position **CLERK**

ii) To discuss whether to allow a lock to be fitted onto the access gate from Bath Road

It was agreed to fit the gate with a combination lock.

i) To consider the consultation plan for Traffic Calming Measures in Bath Road and proposed new layout for Lambs Triangle

The Members agreed to support the Plan for the proposed Traffic Calming Measures, but would like their previous comments made during the pre-consultation to be taken into consideration. (They are concerned about the whether the proposed plans for Lambs Triangle will provide sufficient turning space for buses, and would like three speed cushions rather than the two proposed). **CLERK**

ii) To consider consultation from Highways reference their responding to small scale Planning Applications.
